## OBJECTIVES & INVESTMENT POLICY

### Objective

The Sub-fund's principal investment objective is as a part of a longer term strategy to generate an attractive capital appreciation in SEK.

### Investment Focus

The Sub-fund seeks to achieve its objective by investing principally, either directly or indirectly, in eligible transferable securities, such as equity and fixed income investments, including in-vestments in small-caps and open-ended investment funds and eligible UCITS-Hedge-Funds. The investments shall be overweighted in transferable equity securities and Equity Funds and underweighted in transferable fixed income securities and Fixed Income Funds. In addition to investing in Target Funds, the Sub-fund may invest directly in securities and other eligible financial instruments, such as certificates. For efficient portfolio management and/or hedging purposes, the Sub-fund may use derivatives, like for example non deliverable forwards and non-deliverable swaps.

The Shares in the Sub-fund will accumulate any income. Shareholders may request the redemption of units through the

management company, custodian bank or paying agents at any time. The management company will be required to redeem units for the account of the Fund at the applicable redemption price on any valuation day. The valuation day is defined as every day on which banks and stock exchanges are open for business in Luxembourg. The management company is entitled to temporarily suspend the calculation of the value of units if this is in the best interests of the unit holders and for so long as circumstances persist that require such temporary suspension.

A typical investor should take into consideration that the Sub-fund portfolio has a higher volatility.

Investment in the Sub-fund might entail a slightly higher-average risk and is only appropriate for persons who can accept the possibility of major capital losses.

The Sub-fund is designed for investment only by those investors, who understand the degree of risks involved and believe that the investment is suitable based upon their investment objectives and financial needs.

The time horizon for a typical investor should be 3-5 years.

## CHARGES
